SECTION 4: First aid measures

4.1. Description of first aid measures

General information

First aider: Pay attention to self-protection!

After inhalation

Provide fresh air. Medical treatment necessary.

After contact with skin

After contact with skin, wash immediately with: Water. Subsequently wash off with: Polyethylene glykol 400. Remove contaminated, saturated clothing immediately.

After contact with eyes

If product gets into the eye, keep eyelid open and rinse immediately with large quantities of water, for at least 5 minutes. Subsequently consult an ophthalmologist.

After ingestion

Rinse mouth immediately and drink plenty of water. Do NOT induce vomiting. Potential hazards: Stomach perforation. Call a physician immediately. Do not allow a neutralisation agent to be drunk.

Caution if victim vomits: Risk of aspiration!
